Practical Assessment

A person demonstrating competency in this unit must also satisfy the specific performance and knowledge evidence described below.

The person must:

- identify and orally report two construction hazards
- orally explain how risk could be reduced or removed in relation to those two hazards
- select appropriate personal protective equipment (PPE) to control the risk
- identify and orally explain the meaning of required safety signs and symbols

The person must also demonstrate correctly fitting to themselves the PPE listed below:

- eye protection
- hearing protection
- hard hat
- high visibility retro reflective vest.

IMPORTANT: The above requirements MUST be carried out by <u>direct</u> <u>observation</u> of the student by an Assessor either physically or via audio and visual media in real time (i.e Skype) depending on state regulator requirements.

Completion and provision of certain Identification Documents

As part of the completion of this unit, you will need to comply with the specific requirements of the relevant state regulator, which includes the mode of delivery of the training and assessment, and the provision of certain identification documents. A summary of these specific requirements is provided in this Course Guide.



NEW SOUTH WALES

In NSW, the White Card Course can only be completed by undergoing a 6 hour face to face seminar or virtual seminar (i.e self-paced online White Card courses are no longer permitted in NSW) with an approved provider, and we can offer the White Card seminar in various parts of Sydney and NSW.

WESTERN AUSTRALIA
